**46.0 DECLARATIONS OF INTEREST**

There were no declarations of interest.

**47.0 VISIT BY MR DEWI R WILLIAMS, HEAD OF SERVICE (ENVIRONMENT & TECHNICAL) AND MR DYLAN WILLIAMS, HEAD OF SERVICE (ECONOMIC DEVELOPMENT), BOTH OF ANGLESEY COUNTY COUNCIL, TO DISCUSS THE FUTURE ECONOMIC DEVELOPMENT OF SOUTH-EAST ANGLESEY.**

*It was resolved nem con to go into Committee.*

The Town Mayor welcomed Mr Dewi Williams and Mr Dylan Williams to the meeting.

Mr Dylan Williams began by outlining the responsibilities of the Economic Development Service.

There was a discussion about the potential for developing the Laird's site. Anglesey County Council are in discussion with the owner. The County Council's aspiration is to secure mixed use for the site, possibly including a Community facility. Mr Williams suggested that the Town Council may wish to invite the owner to discuss future developments.

Councillors made the case for investment to diversify the economy of south-east Anglesey. Investment in infrastructure such as better road access was needed in order to encourage a wider range of industry.

The County Council's focus on Holyhead, Amlwch and Llangefni seemed to be confirmed by the current Horizon consultation which does not include Beaumaris. Mr Williams acknowledged the Town Council's frustrations and outlined some of the assistance provided in the Beaumaris area. Mr Williams said that they had

only a relatively small budget and asked the Town Council for suggestions as to where investment should be made.

Councillors expressed their frustration that Beaumaris as a community had 'stood up to the plate' to run the Leisure Centre, yet through Council Tax were still paying for the Leisure Centres in Holyhead, Llangefni and Amlwch, including supporting improvements to them. Mr Williams responded by suggesting that the Town Council should take this up with the County Councillors who set the budgets. He undertook to investigate a suggestion that Visit Wales were investing a large sum in developing those Leisure Centres as wet weather destinations.

The possibility of support for the Tourist Information Point was raised, which would do much to support tourism in Beaumaris, and more widely on Anglesey. In response to a query about road access, Mr Dewi Williams said that funding for road improvements was unlikely (unless there was a prospect of major development) but that parking restrictions in Menai Bridge would be proposed in order to improve traffic flows.

The Town Mayor thanked Mr Dylan Williams for his contribution to the meeting.

Mr Dewi Williams spoke about waste collection on Anglesey. There are challenging targets to be met, and though Anglesey is currently one of the best performing Councils there are unavoidable pressures for changes to collections in 2016/17.

There was a discussion of some practical concerns about recycling. Restrictions at Penhesgyn were in response to abuse of the facility by commercial builders, who should be paying for disposal of rubble etc. The changes have saved Anglesey County Council £200,000 per annum in landfill charges. Vouchers for up to twelve free visits per year with a trailer are available from Llangefni for residents.

Mr Williams said he would investigate the possibility of recycling bins on the front and by the Pier to reduce pressure on litter bins.

Mr Williams outlined the budget pressures on his department, and some of the likely effects which include more public toilets being handed over to communities, less street cleaning (Town Councillors complimented the excellent work of the local street cleaner), cuts in highways maintenance, increased parking charges and a rolling programme of changes to street lighting.

On the issue of parking, Town Councillors made a case for the introduction of a residents' parking scheme to relieve pressures in the town.

In closing, Mr Dewi Williams said that the Flood Alleviation Scheme had got planning permission and that work was intended to start in January.

The Town Mayor thanked Mr Dewi Williams for his contribution.
